Clinic & Laboratory Features (more information available upon request)

Lab: Centrifuge (2), -80° C freezer; CLIA exempt, certificate on file. Staff IATA certified. *Local lab:* LabCorp or AMS Laboratories.

Drug Storage: Double locked room; refrigerator; both ambient and refrigerator are monitored and documented visually every working day and every 10 minurtes a recording is taken by data loggers.

Research/ teaching pharmacy permit on file. SOP in place.

ECG: GE, MAC 1200

Scales: Digital and analogue. Calibrated weekly.

Sphygmomanometers: Each exam room contains both mercurial and digital (Omron, model HEM-705CP).

Maintenance: Performed on centrifuge, blood pressure equipment, ECG, scales annually. Scales calibrated weekly and documented.

Emergency Equipment & Procedures: BCLS certified staff and initiate 911; oxygen. Epinephrine and Benadryl on site. Anaphylactic SOP in place.

Clinic: 5 exam rooms; ICF process conducted in exam rooms. SOPs in place.

CRA: Accommodations for monitors with access to high-speed internet and fax and copier machines.

IRB: Ability to use a Central Institutional Review Board.

Medical Records: Shadow charts obtained from outside offices. eSource in place; 21 CFR Part 11 compliant.

Record Archival: Maintained on site for 2 years post study then archived.

SOPs: All site SOPs are in place and available upon request.
